Head Start | Early Head Start Divison

Head Start (HS)

Head Start prepares our community's most vulnerable young children to succeed in school and in life beyond school. Our program takes a two-generation approach, focusing on building strong parent and child relationships with an overall child goal of increasing school readiness skills. We deliver services to children and families in core areas of early learning, health, and family well-being, while engaging parents as partners every step of the way.

In 2022, we served 452 children aged three-to-five-years old and their families at our center-based locations and through our Home Based programs. We have programs in Licking, Delaware, and Union Counties.

Head Start prepares our community's most vulnerable young children to succeed in school and in life beyond school.

Early Head Start (EHS)

Designed to nurture healthy attachments between parent and child, the Early Head Start program serves infants, toddlers, and pregnant women through one-on-one weekly home visits. We support expectant families as they prepare for the upcoming new family member through a comprehensive approach that focuses on development, nutrition, health, mental health, and education.

In 2022, Early Head Start served 120 infants and toddlers, and four pregnant women.

Freshly Prepared Meals for Children

Proper nutrition is fundamental for children to grow and develop in a healthy manner.

LEADS HS/EHS operates and licenses two kitchens at our Newark and Marysville facilities. The program is proud that all breakfast, lunch and snacks are prepared by Nutrition Staff who are ServSafe-Certified through the County Health Departments. The meals contain required components such as grain, vegetable, fruit, meat and fluid milk for the three to five-year-olds that we serve. We also prepare individual meals for children who may have food intolerances/allergies as well as religious and cultural food requests. As our program utilizes resources from the USDA and CACFP programs, we not only prepare healthy foods but we are able to provide parent education for the families enrolled.

Funding for Head Start and Early Head Start is provided by the U.S. Department of Health & Human Services. The U.S. Department of Agriculture (USDA) provides reimbursement through the Child & Adult Food Program (CACFP) for the meals served to children throughout the year.

Food Service

During the Child and Adult Care Food Program (CACFP) fiscal year, October 2021 through September 2022, LEADS' two kitchens provided:

- 69,826 total meals
- 21,860 snacks
- 23,739 breakfasts
- 3,304 gallons of milk
- 24,227 lunches

The reimbursement through CACFP:

\$ 159,822.28 total food expenses | \$ 64,429.30 non-food expenses

Serving Children with Disabilities

Of the 572 children served, 58 had an Individualized Education Plan (IEP) through their local education agency or education service center. Ten families had an Individual Family Service Plan (IFSP) through their local early intervention agency.

These numbers reflect we exceeded our mandate of having 10% of our enrollment serving children with diagnosed disabilities.

Providing Services to Incarcerated Women with Infants

Early Head Start (EHS) provided services to 15 incarcerated mothers with infants at the Ohio Reformatory for Women (ORW). The program assists the mothers by connecting them to services and programs for a successful return to society.

Serving Pregnant Women

A total of four pregnant women were provided EHS services during the 2022 program year. All of these families continued enrollment after the newborn arrived. Each family is provided a newborn home visit and receives gift packages from Newborns in Need.

Family Engagement

- Head Start and Early Head Start families received a wide variety of parent education and training services, including:
- · Health and safety
- · Nutrition
- · Positive parenting
- · Economic mobility
- · Mental health
- Advocacy, child development and community supports during the pandemic
- Chromebooks were provided for families in need to support virtual learning and communication during the COVID-19 pandemic.
- More than 436 families planned and attended virtual family and father events during the program year.
- 28 parent/guardians volunteered as members of the Head Start/Early Head Start Policy Council and PART (Parent Activities Resource Team)

All 5 Head Start Centers earned a 5-star quality rating, Step Up to Quality (SUTQ), awarded by the Ohio Department of Job and Family Services.

Food Pantries / Food Assistance

LEADS operates food pantries in Buckeye Lake, Pataskala, and Utica. We obtain food supplies from a number of different resources, including donations from businesses, churches, groups/clubs, and individuals, as well as from the Food Pantry Network of Licking County.

- 3,557 eligible households received food from the pantries
- 6.098 hours were volunteered for the pantries

AFFORDABLE HOUSING DIVISION

LEADS Housing Division is an experienced provider of affordable housing. To date, LEADS has participated in 40 housing developments ranging from 15 to 100 units. These developments are located in 21 counties throughout Ohio. Prospective residents must qualify under various income, credit and background guidelines for each of the programs that finance the property. Funding is provided through Low Income Housing Tax Credits, USDA Rural Development, and the US Department. of Housing and Urban Development.

- 1,156 households were provided with affordable housing
- Occupancy rate was 94%
- 269 monthly financial statements were submitted by the management companies to LEADS' Asset Management Director
- 31 properties had audits and tax returns reviewed and approved
- 6 site visits were performed in 2022 with desktop and in-person visits

MAJOR ACCOMPLISHMENTS

- The sale of Greenbriar Estates, a 15-unit conventional property was finalized in July 2022
- The transfer of LEADS ownership in Central Hotel to the City of Galion was finalized in October 2022

Special Recognition: Holly Unger

Holly Unger is passionate about supporting children and families, and has been a tireless advocate for the Head Start and Early Head Start programs at local, state, and national levels.

An Assistant Teacher at the Utica Head Start Center, she has had six children participate in HS/EHS programs since 2015. A biological mom of one, an adoptive mom of nine, and foster parent to 65 children over the past ten years, Holly knows firsthand the importance of crucial early interventions for young children.

She has been a vocal and dedicated advocate for LEADS HS/ EHS programs. She has participated in HS/EHS policy council;



was selected to participate in the Ohio Head Start Association Inc. (OHSAI) Parent Ambassador Program; and traveled to Washington, D.C. to tell her story to legislators.

In 2021 she enrolled in a bachelor's degree program and was hired as an Assistant Teacher at the Utica Head Start Center.

In 2022 she was elected to the OHSAI Board, and re-elected in 2023. In March of 2023, Holly testified in front of Ohio House of Representatives on House Bill 33, Ohio's Fiscal Year 2024-2025

budget bill, regarding the state publicly funded childcare and preschool programs. An excerpt of Holly's testimony is below.

"Head Start focuses on the parents and families just as much as they do the children they serve because they know it's necessary to improve outcomes for kids. They gave us the tools to help make our children's lives so much more than we could have imagined for them, especially given their challenges early in life.

Head Start has been a source of stability, strength, and resources for our family as my husband and I fight for our kids to get them the help they need so that they can develop a strong foundation to serve them for the rest of their lives.

A dedicated, thorough and conscientious employee, Christina started at LEADS in 2013 serving as the Lead Cook of the LEADS kitchen in Marysville. During her tenure, the annual inspections from the Union County Health Department and the Ohio Department of Agriculture have consistently produced stellar reports on the cleanliness and operations of the kitchen.

Christina has always been very cognizant of keeping costs down in the kitchen operation. She utilized her knowledge of a wide variety of allergens and the special dietary needs of children to make appropriate accommodations. She also explored new recipes to present different taste experiences for the children. She has proudly maintained Serv-Safe certification during her time with LEADS.

She shared that working for Head Start has been challenging at times, yet very educational and definitely enjoyable, particularly her interactions with the families at Head Start. She shared a memorable experience: she overheard a parent scolding her child for referring to her as "Lunch". Christina clarified that as she delivered the lunches to the classroom, the children would call out "lunch". Being a literal thinker, this child genuinely thought that her name was "Lunch"!

A believer in the adage that "it takes a village to raise a child", Christina always did her part as a member of our team to provide much-needed services for the health and wellbeing of the children we serve. She has gone above and beyond to help those in need and is often the first volunteer to research and refer for needed services.

Teri Carter



Teri proudly recalls working closely with families and watching them move out of poverty.

Teri Carter ended her dedicated Family Service Worker (FSW) career at LEADS just three months shy of 30 years. She started her career at LEADS while the Marysville site was being built, and during that interim she worked on the second floor of the Delaware junior high school. She recalled that the teachers that were hired conducted home visits to their families while they waited for the site to be completed. Once the site was ready, she filled four classes.

In addition to her job as a Family Service Worker, Teri also dispatched the transportation buses, and during the summer (center administrators did not work year-round at that time), she recruited children and families, gathered bids and ordered supplies. Her recruiting talents resulted in filling an entire classroom in the North Union Elementary building!

In her early days of work she would also transport families to a dentist in Hilliard as there were none in Marysville that would accept Medicaid. She also recalls often delivering meals to the Delaware and Magnetic Springs classrooms.

One unforgettable memory Teri shared was a day she was going door-to-door recruiting in Marysville, when she stepped onto a porch, knocked, and heard a dog growling. As she turned around she spotted a Doberman Pinscher chained to the porch and waiting on the sidewalk! "I slowly stepped off the porch and got away – I thought I was a goner"!

Teri proudly recalls working closely with families and watching them move out of poverty. Teri has worked with staff that she still considers family. She shared that she has been down every country road in Union County while recruiting over the years. We wish Teri numerous future travel opportunities that take her outside of the Maryville community!

Deanna "Dee" Diehl began her career at LEADS in the fall of 1987. Over this time she held various positions within the Head Start program, with over 550 children and families on her caseloads over the years. She cherished memories from each of them and had stated, "Throughout my Head Start career, the most rewarding time was being a Home Visitor! I challenge other staff to go on a Home Visit and see the magic that happens! It is so very rewarding!"

Dee enjoyed spending time with her two children, Seth and Sophia; teaching the 4-H Cloverbuds; camping and swimming with her children; and providing guardianship for her Uncle John. Bud started his career while he still had a full head of hair, first working in weatherization; then as a home repair inspector; and then in maintenance for the HS/EHS division.

Bud was affectionally known as "Scooby Doo" to hundreds of preschool children in the classrooms over the years. When he had a maintenance job to do in the classroom, he would slip into his Scooby Doo persona that the children always enjoyed and would call out to him, "Hi, Scooby Doo!"

Bud reported that he enjoyed his job and the people he worked with over the years, but the favorite part of his job was "being around the kids." He recalled a favorite memory, when staff member JoAnn Slaughters' son Adam was out on the playground as Bud was painting the tricycles. Adam couldn't wait and leapt upon a freshly painted bike seat, covering his pants in paint – and then proceeded to tell Bud he had to buy him new pants!

Bud reminisced on how things evolved over the years, recalling times when he had to change the oil and brakes on the agency vehicles instead of taking them to be serviced. Ever resourceful, Bud would also stop alongside the road to pick up discarded items to creatively use in some fashion at LEADS.

Other favorite feel-good moments were when Bud would make gift items for staff to honor them and as presents during the holidays.

Bud retired in October 2022, and has been tending his yard and house while his wife Robin continues to work. He is also enjoying doing maintenance for a local social club.




